**The u3a Henderson Constitution includes the following clauses relating to its membership:**

### **2.1 OBJECTS OF THE ASSOCIATION**

The objectives of the Association are to further the knowledge and interests of people in the community aged 50 and over who are retired or semi-retired.

### **3. MEMBERSHIP**

**3.1** Persons seeking membership of the Association shall make an application to the Committee on the prescribed application form. The Committee may approve or decline applications at its absolute discretion.

The applicant:

- (i) Must agree to support and continue to support the objectives of the Association whilst remaining a member.
- (ii) Shall abide by any conditions properly decided by the Committee; and
- (iii) Shall pay the annual subscription as determined at the annual general meeting.
- (iv) The Committee shall have the right to reduce or remit individual membership fees.

### **3.2**

(ii) The Committee may decide limits on the maximum number of members of the Association.

### **3.3**

The Committee may terminate membership of any member if:

- (i) There is any money owed to the Association in respect of membership or other fees.
- (ii) In the opinion of the Committee that member acts in a way which is prejudicial to the Association or brings it into disrepute.

### **3.4**

Any member may resign from the Association by communicating this intention to the Secretary, in writing.

### **3.5**

It is expected that all members (except Honorary Members) shall:

- (i) Join and actively participate in at least one Study Group of the Association each year. An exclusion is required with a reason for not joining a Study Group.
- (ii) Normally attend monthly meetings.
